**SUBJECT: SUPPLY AND DELIVERY OF ONE (1) UNIT TRUCK WITH FREEZER AND CHILLED BODY SYSTEM AND ONE (1) UNIT TRUCK WITH CHILLED BODY SYSTEM (REBID)**

WHEREAS, the aforementioned request was approved as detailed below:

WHEREAS, the Philippine Carabao Center (PCC), an attached agency of the Department of Agriculture, was created by virtue of Republic Act No. 7307;

WHEREAS, PCC is mandated to conserve, propagate and promote the Carabao as a source of draft animal power, milk, meat and hide to benefit rural farming families thereby improving their general well being, through Carabao genetic improvement, technology development and dissemination;

WHEREAS, in order to attain the above objectives, the procurement of supplies, services and other materials are needed to sustain operations;

WHEREAS, in accordance with Sections 3 and 4, Article I of Republic Act No. 9184 and Sections 4.1, Rule I of its Implementing Rules and Regulations (IRR), public bidding is required in the procurement of infrastructure projects, goods and consulting services;

WHEREAS, funds for the purpose is available;

WHEREAS, the Invitation to Bid (ITB) for this requirement was published in the Philippine Daily Inquirer and posted in the Philippine Carabao Center official website on December 4, 2013 and simultaneously posted in the following:

- a. PhilGEPS Official Website
- b. Conspicuous places in the premises of the procuring entity

WHEREAS, in response to the Invitation to Bid, the following Bidders secured the bidding documents:

- 1. Balfront Industries and Equipment
- 2. Union Motor Corporation

WHEREAS, the Pre-bid Conference was held on December 10, 2013 (10:00 a.m.) at the PCC Shahani Room, National Headquarters and Gene Pool, Science City of Munoz, Nueva Ecija. Clarifications therein raised were incorporated in Bid Bulletin No. 1 posted in the PhilGEPS Official Website and issued to all bidders, copy of which is attached;

WHEREAS, the Opening of Bids was held on December 23, 2013 (11:00 a.m.) at the PCC Shahani Room, National Headquarters and Gene Pool, Science City of Munoz, Nueva Ecija participated in by the following bidders:

1. Balfront Industries and Equipment
2. Union Motor Corporation
3. FRS Construction & Spare Parts Co. Ltd.

WHEREAS, RA 9184 provides that opening of eligibility documents shall be based on a non-discretionary pass/fail criteria;

WHEREAS, two (2) bidders who submitted, the complete set of eligibility and technical components and complied with the requirements and were considered for the opening of the financial proposal;

WHEREAS, a summary of financial proposals is as follows:

WHEREAS, the bidders were advised that the submitted documents shall still be subjected to bid evaluation and post-qualification;

WHEREAS, a joint evaluation was undertaken, composed of the PCC's BAC-Technical Working Group (TWG) and end-user, and the following observations were made:

1. 1 unit Truck with Freezer and Chilled Body System	Balfront Industries and Equipment	P 1,370,000.00 The Lowest Calculated Bid (Balfront Industries and Equipment) was not complying with the basic specifications of the end-user, thus declared as "Non-Responsive".
	Union Motor Corporation	P 1,375,120.00 The bidder complies with the basic specifications of the end-user.  The proposal of the bidder (Union Motor Corporation) was declared as the "Lowest Calculated Responsive Bid".
2. 1 unit Truck with Chilled Body System	Balfront Industries and Equipment	P 1,300,000.00 The Lowest Calculated Bid (Balfront Industries and Equipment) was not complying with the basic specifications of the end-user, thus declared as "Non-Responsive".

WHEREAS, after review of the findings, the BAC resolved to consider the recommendation of the PCC-BAC's TWG;


WHEREFORE, PREMISES CONSIDERED, THE COMMITTEE RESOLVES AS IT IS HEREBY RESOLVED that:

- a) **UNION MOTOR CORPORATION** be awarded the contract for Item No. 1 being the Lowest Calculated Responsive Bid (LCRB) in the amount of **One Million Three Hundred Seventy Five Thousand One Hundred Twenty Pesos (P 1,375,120.00)**; and
- b) **UNION MOTOR CORPORATION** be awarded the contract for Item No. 2 being the Lowest Calculated Responsive Bid (LCRB) in the amount of **One Million Three Hundred Two Thousand Eight Hundred Eighty Pesos (P 1,302,880.00)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **PHILIPPINE CARABAO CENTER (PCC)** now invites bids for the **SUPPLY AND DELIVERY OF ONE (1) UNIT TRUCK WITH FREEZER AND CHILLED BODY SYSTEM AND ONE (1) UNIT TRUCK WITH CHILLED BODY SYSTEM (REBID)**. Delivery of the Goods is required within 60-90 calendar days. Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from **PHILIPPINE CARABAO CENTER (PCC)** and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.


