**CONTRACT AGREEMENT FORM**

THIS AGREEMENT made on the 1-8-2014 between the **PHILIPPINE CARABAO CENTER**, an agency of the Government of the Philippines with address at Science City of Muñoz, Nueva Ecija, represented by its Executive Director, **DR. LIBERTADO C. CRUZ** hereinafter called the **PROCURING ENTITY** of the one part and **UNION MOTOR CORPORATION** a business entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at 198 EDSA cor. Tandang Sora St., Kalookan City represented by **MR. EMERITO B. CASTILLO** hereinafter called as the **SUPPLIER**.

WHEREAS the Entity invited Bids for the **SUPPLY AND DELIVERY OF ONE (1) UNIT TRUCK WITH FREEZER AND CHILLED BODY SYSTEM AND ONE (1) UNIT TRUCK WITH CHILLED BODY SYSTEM (REBID)** and has accepted the Bid by the Supplier in the amount of PESOS: **Two Million Six Hundred Seventy Eight Thousand Pesos (P 2,678,000.00)** called as the "Contract Price".

3. In consideration of the payments to be made by the **PROCURING ENTITY** to the **SUPPLIER** as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the **Contract Price** or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


