**Subject: BAC RESOLUTION DECLARING FAILURE OF BIDDING**

WHEREAS, the PHILIPPINE CARABAO CENTER (PCC) advertised the Invitation to Bid (ITB) for the SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) UNIT REFRIGERATED CONTAINER in the Philippine Carabao Center official website on February 13, 2014 and simultaneously posted in the Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the premises of the procuring entity;

WHEREAS, in response to said advertisements, one (1) prospective bidder named NHJ Horizon, Inc. purchased Bidding Documents;

WHEREAS, on February 21, 2014, the Bids and Awards Committee (BAC) conducted the Pre-bid Conference participated in by the sole bidder;

WHEREAS, on March 5, 2014, the Bids and Awards Committee (BAC) conducted the Bid Opening but the lone bidder failed to submit the bidding documents on the specified time stated in the Philippine Bidding Documents (PBD) for the said project;

WHEREAS, Sec 35.1 of Republic Act 9184, or the Government Procurement Reform Act, states:

"Section 35. Failure of Bidding. The BAC shall declare the bidding a failure if:

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to recommend for the Head of the Procuring Entity to declare **FAILURE OF BIDDING** for the SUPPLY, DELIVERY AND INSTALLATION OF ONE (1) UNIT REFRIGERATED CONTAINER pursuant to Section 35 of RA 9184;


RESOLVED further, to recommend that the Rebidding for said Procurement be conducted immediately.

Adopted this March 5, 2014 at Philippine Carabao Center, National Headquarters and Gene Pool, Science City of Munoz, Nueva Ecija.


