Subject: BAC RESOLUTION DECLARING FAILURE OF BIDDING

WHEREAS, the PHILIPPINE CARABAO CENTER (PCC) advertised the Request for Interest (REI) for the ARCHITECTURAL AND ENGINEERING CONSULTANCY SERVICES FOR DESIGN WITH CONSTRUCTION SUPERVISION FOR THE ANIMAL PERFORMANCE TESTING FARM (PCC-CMU) in the PCC official website on November 27, 2013 and simultaneously published it in the Philippine Daily Inquirer as well as posted it in the Philippine Government Electronic Procurement System (PhilGEPS) website and conspicuous places in the its premises;

WHEREAS, in response to said advertisements, three prospective bidders purchased Bidding Documents, namely, A.C Ong Consulting Inc., FR Villegas Architects Engineers Consultants and P-SquareAssociates Co.;

WHEREAS, on December 3, 2013, the Bids and Awards Committee (BAC) conducted an Eligibility Check and three bidders were shortlisted;

WHEREAS, on December 11, 2013, the BAC conducted the Pre-bid Conference participated in by the three shortlisted bidders;

WHEREAS, on December 23, 2013, the deadline for the submission and opening of bids, the three shortlisted bidders submitted their respective bids;

WHEREAS, during the course of the opening and evaluation of the respective bids submitted by the three bidders, the BAC found that all the three bids did not comply with the bid requirements and instructions to bidders and consequently declared all of them disqualified;

WHEREAS, Sec 35.1 of Republic Act 9184, or the Government Procurement Reform Act, states:

“Section 35. Failure of Bidding. The BAC shall declare the bidding a failure if:

xxx xxx xxx

(c) All bids fail to comply with all the bid requirements

Xxx xxx xxx.”

NOW, THEREFORE, the Bids and Awards Committee RESOLVES, as it is hereby RESOLVED, to declare FAILURE OF BIDDING for the project ARCHITECTURAL AND ENGINEERING CONSULTANCY SERVICES FOR DESIGN WITH CONSTRUCTION SUPERVISION FOR THE ANIMAL PERFORMANCE TESTING FARM (PCC-CMU) pursuant to Section 35 of RA 9184;

RESOLVED further to recommend that the Rebidding for said Project be conducted immediately.
